The deadline for all submissions is **Monday, 14 July 2025, at 12:00 noon (HKT)**. Late applications will not be considered. Towards the application deadline, the online system may be overloaded due to the large volume of applications. To ensure timely completion of your online application, it is advisable to submit the application as early as possible.
